Philanthropy Impact is a unique international membership organisation. It is a UK Registered Charity (1089157) and Company Limited by Guarantee (England & Wales) (3625777) operating predominantly in the UK, Ireland and Europe, and working in partnership with leading companies and organisations within the philanthropy arena. In the last financial year, Philanthropy Impact presented 20 events, at which over 870 participants engaged with national and international experts.

Trustees play an active in role in the governance and support of this effective and growing organisation. Trustees are encouraged to participate on sub-committees (Finance, Governance & Nominations, Body of Knowledge, Public Affairs or Fundraising). Trustees also attend Philanthropy Impact events throughout the year, and where appropriate may host such events themselves. Trustees are elected for a term of three years, with potential for a further three-year term. For the last two years, each one of our trustees has personally contributed to the Campaign for Modern Philanthropy.

The Board meets four times a year and is chaired by Grant Gordon. Meetings are held in English and attendance can be via conference call.
